The turn-out for the annual meeting of the ABA at the MLA convention in Los Angeles this year was disappointingly small—a little better, instead, at the annual reception. We were honored at both the meeting and party by the presence of Vittore Branca. Professor Branca expressed an interest in the ABA and reported on our activities in the recent AISLI Newsletter.

Plans are underway for new ABA activities, and John Ahern's proposal for a Lectura Boccacci is included in this issue of the Newsletter. There will be two meetings of the planning committee in Italy this summer, the first on Sunday, June 26th at 11:30 a.m. at Via Vecchia Fiesolana, 48, S. Domenico di Fiesole (for information call Elissa Weaver in Florence at 055 59-132 after June 15) and the second will be at the Casa di Boccaccio in Certaldo in the Sala della Biblioteca on Saturday, July 30th at 11 a.m. (for further information call Michelangelo Picone in Certaldo at 0571 66-58-27 after July 20th).

The fall Newsletter will publish a review of Joy Potter's recent study of the Decameron, Five Frames for the Decameron, Princeton University Press, 1982. It has been suggested repeatedly that the Newsletter would be a convenient vehicle for an annual Boccaccio bibliography; members interested in compiling such a bibliography or in collaborating in a group effort to do so, please contact the ABA secretary-treasurer Paolo Giordano.

#### LECTURA BOCCACCII: A PROPOSAL

Compared to scholarship on Dante's Comedy, scholarship on the Decameron is in its infancy. A glance at Esposito's and Kleinhenz's bibliography for 1939-1979 shows that many novelle have not recently received serious critical attention in Italian or any other language. Two decades ago this situation began to improve. The founding of Studi sul Boccaccio by Vittore Branca in 1963 marks a new era. In the sixth issue of SsB Anna Laura Lepschy's Bibliography of Anglo-American scholarship from 1945-1969 presented a negative picture in striking contrast to what would soon occur. In the past twenty years Boccaccio scholarship on the North American continent has blossomed. The founding of this Association is testimony of this. Readers of this newsletter are well aware of the outpouring of ground-breaking books, articles and translations which are transforming our understanding of the Decameron.

To help direct some of this energy I propose that the ABA organize a series of public readings of all 100 novelle as well as the cornice, to be published later in 10 consecutive volumes. There would be three readings a year at the annual meetings of the MLA, the AAUPI, and the International Congress of Medieval Studies in Kalamazoo. The speaker would be charged to present in the span of an hour a lively, original and detailed reading of part of the Decameron to a broad academic audience. The published form of these readings would be longer, fuller and amply documented. The uniqueness and completeness of this enterprise would guarantee it a wide following among intelligent readers of Boccaccio, academic or not, undergraduates, graduate students, medievalists, Italianists and Boccaccio specialists. These volumes would soon become indispensable and would be certain of steady sales to college and university libraries, as well as public libraries here and in Italy.

I suggest the following time-table. This year at the annual meeting during the MLA convention in New York there would be open discussion of the project. At that time I will present a resolution that the President name two others to a Lectura Boccaccii Committee on which she will serve along with the Vice President and Secretary. By March 1, 1984 this Committee will submit to the members for voting a formal proposal that the ABA sponsor such a series. (To facilitate the work of this Committee, interested members could begin sending the President their ideas about this project now.) Assuming that this proposal would be accepted, the Committee would appoint the editor of the first volume, who in consultation with it would establish length and format and choose contributors from both established and junior scholars. Work published elsewhere would be avoided. The editor's task would be to stimulate new and original work, of the highest possible quality and employing a variety of critical methods. The first lectura could be scheduled for the 1985 meeting of the MLA.

## (LECTURA BOCCACCII: A PROPOSAL)

Assuming three lecturae annually, and eleven lecturae in each volume, the First Day would be completed by spring 1988, and could appear in print sometime in 1989. The series would probably continue into the third decade of the next century. In this way it will stimulate scholarship on the entire Decameron for the next thirty or forty years. To increase the number of annual readings, or to make this solely a publishing venture without public readings might, I think, blunt the effectiveness of this enterprise.

The financing of these lecturae should be worked out volume by volume. When the first volume is well underway, we will have the information necessary to take the proposal to the foundations. The support of the ABA and the promise of solid library sales should make obtaining grants and finding a publisher not insurmountable tasks.

## ANNUAL MEETING - DECEMBER 1982 LOS ANGELES

## MINUTES

The meeting was opened by Professor Elissa Weaver at 3 p.m.

## 1. Acceptance of Minutes

The minutes of the 1981 business meeting were accepted as written.

## 2. Treasurer's Report

As of November 30, 1982 the Association has a balance of \$385.62 in its checking account with the University National Bank of Hyde Park, Illinois.

## 3. Professor Weaver made the following announcements:

- a) The Newberry Library Center for Renaissance Studies is pleased to announce its 1983 Summer Institute in the Archival Sciences, which will be led by Professor Armando Petrucci, Director of the Institute of Paleography, the University of Rome. Assisted by Professor Franca Nardelli, Dr. Petrucci will provide intensive training in the reading, transcribing, and editing of Italian vernacular manuscripts (1300-1650). He will also offer a thorough orientation in the organization of Italian archives, libraries, and manuscript collections.
- b) The Association will hold its annual party at the Biltmore Hotel this evening at 6:00 in Professor Weaver's suite.
- c) A book of interest to ABA members has just been published by Pratiche (Parma, 1982). Il Testo moltiplicato is a collection of five essays representing different approaches to the study of the novella of Lisabetta and the pot of basil (Decameron, IV, 5) by Barato, Serpieri, Segre, Nencioni and Cirese.

## 4. Old Business

There was much discussion about the Association's Newsletter and how possibly to improve it. Various suggestions were made:

- a) Solicit reviews of works on Boccaccio
- b) Professor Marga Cottino Jones suggested that part of each fall Newsletter be dedicated to a systematic bibliography of recent Boccaccio studies and that people be urged to send bibliographical information to the editors.

#### 5. New Business

Professor Weaver announced that the Association is planning to undertake a major project, a *Lectura Boccaccii* devoted to the Decameron, stories and framing tale.

At the executive council meeting preliminary discussions were held, and it was decided to hold two meetings of the planning committee this summer in Italy--one in Florence in June and a second in Certaldo in late July at the house of Boccaccio.

The meeting adjourned at 3:30 p.m.
