NEWBERRY LIBRARY 1988 SUMMER INSTITUTE IN ITALIAN ARCHIVAL SCIENCES

Once again the Newberry Library in Chicago will offer a six-week summer institute in the archival sciences, from June 27 to August 5, 1988. The institute will be lead by Professor Armando Petrucci, Director of the Institute of Paleography at the University of Rome. With the assistance of Dr. Franca Nardelli, Prof. Petrucci will provide intensive training in the reading, transcribing, and editing of Italian vernacular manuscripts from 1300-1650. In addition he will offer an orientation in the organization of Italian archives, libraries, and manuscript collections.

Stipends of up to \$3000 are available through the National Endowment for the Humanities to full-time faculty members and librarians with

instructional responsibilities employed in institutions of higher learning in the United States. In accordance with NEH guidelines, institutions of participants receiving NEH awards will be required to pay 10% (\$300) of the stipends. Special funds are also available to faculty, research scholars, and advanced graduate students at universities affiliated with the Newberry Library Center for Renaissance Studies or the Folger Institute.
