## Members Report Activities

**Linda Carroll** (Tulane Univ.) is currently studying Ruzante's use of Boccaccio.

In the spring of 1996 the Univ. of California at Los Angeles sponsored a Boccaccio Colloquium in honor of Francesco Bruni, visiting professor for Spring 1996 in the Dept. of Italian. Among the participants were Franco Fido (Harvard Univ.), **Pier Massimo Forni** (Johns Hopkins Univ.), Patrick Rumble (Univ. of Wisconsin - Madison), and **Marga Cottino-Jones** (UCLA).

The Univ. of Michigan Press will soon publish a new book by **Robert Hollander** (Princeton Univ.), *Boccaccio's Dante and the Shaping Force of Satire*. Hollander's essay, "Boccaccio, Ovid's *Ibis*, and the Satirical Tradition," will appear in the *Atti del Convegno: Gli Zibaldoni di Boccaccio*. His essay, "Day Ten of the *Decameron*: The Myth of Order," co-authored with Courtney Cahill, has appeared in *Studi sul Boccaccio* 23 (1996).

**Victoria Kirkham** (Univ. of Pennsylvania) participated in the international conference, *Gli Zibaldoni di Boccaccio: memoria, scrittura, riscrittura*, held in Florence and Certaldo April 26-28, 1996. Her paper, "Johannes de Certaldo: la firma dell'autore," will appear

in the *Atti del Convegno*, edited by C. Cazalé-Berard and M. Picone.

The German Minister of Culture recently conferred upon **Karl-Ludwig Selig** the title of Honorarprofessor. Selig has been visiting professor of the Universität Greifswald for almost five years now.

## Newberry Notices

Two upcoming Newberry Library offerings may be of interest to Boccaccio scholars. "Latin Paleography from the Age of Charlemagne to the Age of Humanism" will survey the evolution of Western script and manuscript production from *circa* 800 to the Renaissance. Participants will learn how to identify and read a broad range of scripts, from formal book hands to cursive charter hands. The course will include training in the fundamentals of codicology; a basic reading knowledge of Latin is required. Taught by Timothy Graham, visiting international scholar at Western Michigan Univ., the course will meet Wednesdays from 1:30 to 4:30 p.m., beginning February 5 and ending April 16.
